Wire transfer, certified or personal check accepted. The balance will be due at closing.

POSSESSION: Full possession will be given on 1/1/2024 for Tract 1 and at closing for Tract 2 and 3.

TAXES: Seller shall pay the 2023 and previous years taxes. The 2024 will be paid by the buyer.

RENTS: All rents for the 2023 crop year will belong to the seller.

TITLE: Seller to convey title by warranty deed. Merchantable title will be made available. The cost of title insurance and escrow closing fees to be divided equally between the buyer and seller. Title insurance and escrow services will be provided by Nebraska Title in Kearney.
