Correction: 7/15/2024 2:01:51 PM 13044 Pre-inspected tractor for overheating issues, I didn't feel any air being sucked in through the radiator I put a flashlight through the fins and saw that there was major debris in the radiator and pre cooler. First I removed the hood spring mounts and lowered the hood further. I removed the condenser, pre cooler bolts, brackets, and radiator hoses. I power washed the condenser, pre cooler, and radiator fins until I could see through the fins with a flashlight. Without vacuuming the A/C system I was able to flip the condenser laying on top of the engine. I did have to grind off the bottom passenger side pre cooler/condenser bolt and nut due to the nut being rounded off and I replaced that as well. Next I installed the pre cooler and condenser in order and tightened the bolts and brackets. Installed the hood spring mounts, and connected the radiator hoses back on.

7/18/2024 9:04:58 AM 10806 Took unit for a test drive the coolant gauge was not getting above 150 degrees. Replaced the thermostat in the unit removed the charge air piping and intake system piping and removed the a/c compressor belt. Moved the a/c compressor out of the way and drained the coolant then removed the upper radiator hose out of the way. Removed the thermostat housing found it was pitted removed the seal and took to sand blaster cleaned up all sealing surfaces looked good installed new seal and thermostat then installed. Took the unit for test drive now the ecm temp was reading 189 degrees but the coolant temp was showing 150 degrees with temp gun. Checked over wires found the ends were showing bear wire repaired the ends then touched together the gauge went to high temp then disconnected the gauge was not reading. Found all wiring to gauge was good. Took another temp gun and checked it was reading with the ecm temp on thermostat outlet the coolant temp sender had failed. Removed the sender the sensor was stuck in the adapter. Got sensor removed from the adaptor new sender adapter could not find new adapter. Installed sender and filled with coolant then test drove gauge was now working correctly.


